Residents enjoy an average rainfall of less than 20 inches a year, and a very comfortable average daytime temperature of 27 Celsius, making it the perfect place to enjoy life outdoors, and with so many water sports and other outdoor activities on offer, Aruba is the perfect location to live, and vacation.

BUYING REAL ESTATE - HOW TO...

Before you start your search, the good news is, contrary to what you may have heard, there are no special requirements for non-residents who want to buy property in Aruba, in fact the process is the same as it is for a resident.

In Aruba there are two types of land upon which houses are built:

- 1. Freehold property land this is the type of land that is owned outright by the owner of the deed.
- 2. Lease Land This type of land is owned by the Land of Aruba and a 60-year lease has been given. For these lease rights you pay a yearly fee. Many non-residents have bought lease land or homes situated on lease land.





The most important thing to remember when you start your search for your new home, is to not go it alone, the help of an experienced realtor will help you to keep your search realistic, within budget and make the buying process less stressful.





Make a list of needs and wants for your new home, and take them with you to your realtor, you can then narrow the search and only visit the properties that will be right for you.



Once you have chosen the perfect property, your next steps are:

- Hire a lawyer (We can help you with this) so that you can make an offer on the property
- Once your offer has been accepted, your Coldwell Banker Aruba Agent will draw up the preliminary sale/purchase agreement for you and the vendor to sign, this document reserves the property for you
- Pay the deposit of 10% at the notary of your choice
- You will then need to settle all closing costs, such as the transfer tax, and notary charges
- Once the process is complete, you will then be ready to collect the keys to your new home





When buying a home, you will incur closing costs, these costs are approximately 5 to 8 percent of the selling price, and are calculated as follows:

- Transfer tax, (one-time tax), three or six percent of the selling price, depending on the value.
- Notary fees transfer deed: one percent of the selling price
- Notary fees mortgage deed (if applicable): one percent of the selling price.

The entire process usually takes around 6-8 weeks to complete, depending on the complexity of the transaction.





PROPERTY TAX

The only yearly property tax you have to pay is called land tax, this tax is usually based on the selling price. The first USD 34,000.00 is free of tax, and on the balance you pay USD 4.00 per USD 1,000.00 of the value.

Other Taxes in Aruba

Aruban citizens are taxed on their international income, whereas non-residents are taxed only on income earned in Aruba.

Other taxes charged in Aruba include:

- Income Tax
- Inheritance Tax
- Social Security
- Excise Tax
- Room Tax/Tourist Tax
- Corporate Tax





GETTING A MORTGAGE

If you need financing to make your dream home in Aruba a reality, our local banks offer mortgages to both residents and non-residents, each bank will have their own list of requirements for mortgage applications, for instance:

- Identification
- Bank reference letter
- Employment reference
- Copies of appraisal reports and sales agreements

Banks in Aruba typically lend 60% of the value of the property with a closing fee of approximately 1.5% of the total loan amount





VISITING ARUBA

Tourists are free to enter Aruba without a written permit, so long as they do not stay for a period longer than 30 days. The maxiumum time a person can stay in Aruba cannot exceed 180 days per year.

Extension of stay

When entering Aruba, the following people can request an extension of their stay for up to 180 consecutive days.

- Nationals of the Kingdom of the Netherlands
- Residents of any country which has an agreement with the Kingdom of the Netherlands to abolish the visa obligation if -
 - * They have a property in Aruba, or a pleasure yacht moored in Aruba with a length of at least 14 meters. Proof of ownership must be available.






Tourists are not permitted to work or look for work during their stay, neither are they allowed to do business.

All tourists should have:

- A return ticket, or a ticket for onward travel outside Aruba
- The correct documents for their return home or next destination
- Enough money to support themselves for the duration of their stay.

Aruba also has US pre-clearance, so that once you have enjoyed your vacation in Aruba, you will arrive back in the US as a domestic passenger arriving back from any other point in the US -

- After check in you will take your baggage to the US Customs and Border Protection facility, where an officer will run a computer check and take your customs forms.
- Once you are cleared, your luggage will be put on the plane and you will go to the gate and board. Once you land back to the US this process allows you to arrive as if you were any other domestic passenger.





RELOCATING TO ARUBA

If you want to relocate to Aruba, you will need a residency permit, it is important to note that this residency permit does not allow you to work in Aruba, in order to work here, you will need to apply separately for a work permit (see Page 14)

Requesting a residence permit must be done in person, or by an appointed representative at the Department of Immigration (Dimas) and you will need:

- Bank references
- Home and business addresses for the last 10 years
- The reason you want to live in Aruba
- Police clearance (not older than 2 months)
- Passport valid for Aruba
- Three passport Photos
- Valid vaccination for smallpox
- A medical declaration to confirm you are free from any contagious or mental illness, within 30 days of your trip
- Proof of payment of the legal fee

WORKING IN ARUBA

Finding employment as a non-Aruban is not easy, and the only time a work permit will be issued is when there are no local qualified staff available for positions. Without a valid work permit you are not allowed to work and could be deported from the island.

In general, the application for a work permit will only be considered if filed by an employer, who is willing to accept full responsibility for any expenses imposed by the government for the employee.

Written Permits

Not including tourists, all other persons should have a written permit to prove their legal right to be on the island.





A LITTLE HISTORY OF ARUBA

1,000's- The Arawak Indians arrived as the first inhabitants of the island. They migrated north from the Orinoco Basin in South America.

1499- Alonso de Ojeda the Spanish explorer arrived on the island, and claimed the island for Queen Isabella, however the Spanish left soon after due to the island's lack of gold.

The island was abandoned and left to the Caiquetios for the next 150 years, and before long the island became a hideaway for pirates and buccaneers who preyed on ships transporting Indian treasures back to the old world.

1636- The Dutch captured Aruba, so that they could establish another colonial presence, having been expelled from St Maarten.





1805 – 1815 - The island fell under British control during the Napoleonic wars, before returning to Dutch control.

1824- gold was discovered near Bushiribana marking the beginning of the gold rush which lasted until 1916 when it became unprofitable and shut down.

1929- Aruba became home to one of the world's largest oil refineries.

1985 – The refineries closed down and tourism became a very important industry. Oil refining was resumed in 1991 however the island continues to invest heavily in tourist development, and is the island's primary economy.

Internet Speed in Aruba


One of the most important factors to consider for may of us when we move is the internet speed available in the new country or area, we have included the details below

ARUBA FAQ

Can I Drink the Tap Water in Aruba?

There is no need to buy bottled water in Aruba, the tap water is fresh and pure, in fact it meets the highest standards of quality of the World Health Organisation.

What time zone is Aruba in?

The local time in Aruba is Atlantic Standard time (GMT+4) all year. Daylight Saving Time has never been used here.

What Languages are Spoken in Aruba?

The official languages of Aruba are Dutch and Papiamento, however there is no need to hire a translator as English and Spanish are also both widely spoken.

What is the percentage of Consumer Tax?

The current consumer tax rate is 1.5%.

Is Aruba in the Hurricane Belt?

Aruba is South of the hurricane belt meaning that direct hits from hurricanes are rare.

Aruba's currency is the Aruban Florian, denoted by the letters Awg, and Afl. The currency is linked to US Dollars, therefore fluctuates with the US Dollar.

What are the Liquor and Drug Laws in Aruba?

The legal drinking age in Aruba is 18 for drinking beer, wine and spirits. Drinking is allowed on the beach but ensure you remove all bottles as they have very strict litter laws. Aruba has very strict laws against drugs, all drugs are illegal.

Can I Retire in Aruba?

Aruba has a special program for retirees who want to retire in Aruba. In order to qualify for this a person needs to be 55 years or older and have a minimum annual income of US\$56,200 from a pension or other legal source. The person must also own a home on the island.
